# What do Prince, Picasso, Jimi Hendrix, Abraham Lincoln, Sonny Bono and Wild Bill Hickok all have in common?

You're probably thinking, not much. But they do, in fact, have one big thing in common. They all died intestate—which means, they died without having a will. Surprising as that might sound, even the rich and famous can fail to plan ahead when it comes to their estate.

Here's a snippet of 10 famous people who died without wills and what happened to their estates.

#### 1.Jimi Hendrix

Although Jimi Hendrix died in 1970, the battle over his estate raged on for more than 30 years for one simple reason: Hendrix left no will regarding distribution of his estate. To complicate matters, the estates of musicians and other artists often continue to generate money long after their deaths.

#### 2.Bob Marley

Like Jimi Hendrix, Bob Marley's estate continues to generate significant revenue despite the fact that Marley died in 1981. Also like Hendrix, Bob Marley died intestate even though he knew he had cancer and lingered for nearly 8 months. His estate, worth a reported \$30 million, had dozens of claimants.

#### 3. Salvatore Phillip "Sonny" Bono

Granted, Sonny Bono "the politician" died an untimely death in a skiing accident in 1998, but why he died without a will is something we'll never know. Instead of staying at home to grieve, his widow Mary Bono headed to the courthouse to be appointed the estate's administrator. Ex-wife Cher showed up on the scene as a claimant in Bono's estate and a "love child" surfaced soon thereafter making the situation even more difficult.

#### 4. Stieg Larsson

Swedish author Stieg Larsson who wrote *The Girl with the Dragon Tattoo* among others, died in 2004. Like many others, Larsson died without a will and Swedish law dictated that Larsson's estate was to be divided up between his father and his brother. His lifelong partner of 32 years, Eva Gabrielsson, received nothing, although the family did grant her ownership of the couple's apartment.

#### 5. Pablo Picasso

Pablo Picasso died in 1973 at the age of 91, leaving behind a

fortune in assets that included artwork, five homes, cash, gold and bonds. Because Picasso died intestate and left no will, it took 6 years to settle his estate at a cost of \$30 million. His assets were eventually divided up among six heirs.

#### 6. Michael Jackson

Although a will was later discovered, immediately following Michael Jackson's death in July 2009, his mother filed court papers claiming that Jackson died intestate. Like Hendrix and Marley, Jackson's estate continues to generate money. In the year since his death, his estate generated over \$242 million.

#### 7. Steve McNair

NFL player Steve McNair had it all—fame, fortune, and a beautiful family. But when 36-year-old McNair was shot and killed by an alleged girlfriend, who is believed to have committed suicide after killing McNair, the truth came out—that he had, in fact, had a girlfriend and he never bothered to create a will.

#### 8. Howard Hughes

Howard Hughes was an eccentric billionaire who died in 1976 at the age of 70. When he died, his will was discovered at the headquarters of the Mormon Church in Salt Lake City. The will, however, was proved to be a forgery in a Nevada court and his estate was divided among his 22 cousins.

#### 9. Abraham Lincoln

Abraham Lincoln, the nation's 16th president, has the distinction of being the first president to be assassinated (1865) as well as the first president to die intestate—despite being a lawyer himself.

**10.** Wild Bill (James Butler) Hickok was gunned down by Jack McCall, a desperado from Texas, McCall shot Wild Bill in the back, and was hanged for the shooting, never revealing his motive. Hickok, a Union army spy, a scout for General Custer, a marshal for Abilene, Kansas, and a crack shot with a pistol, was handsome, longhaired, and a flamboyant gambler. Died without a will.

Famous or not, everyone should have a will. It's simple to do and it saves your family a lot of money and headaches. And, as illustrated by the stories above, you're never too young—or too smart or too powerful—to have a will.

# IMPORTANT 2021 UPDATES/REMINDERS & WHAT YOU NEED TO KNOW TO PLAN FOR 2022

## COVID-19 EMERGENCY PAID SICK LEAVE EXTENDED

The temporary COVID-19 Massachusetts emergency paid sick leave (MA EPSL) has been extended through April 1, 2022.

In spring 2021, Massachusetts established a statewide mandate for employers to temporarily provide employees up to 40 hours of MA EPSL when they are unable to work due to specific qualifying reasons related to the pandemic, including contracting

COVID, quarantining, and vaccinations. The law was set to expire on September 30, 2021, but a legislative amendment has extended the law through April 1, 2022. In addition, the new law extends the coverage of the MA EPSL to allow leave to care for family members receiving immunization or recovering from immunization.

The MA EPSL benefit is in addition to existing paid time -off benefits offered by employers or required by law (such as Earned Sick Time), subject to some limited exceptions. Although all employers (except the federal government) must provide the MA EPSL, they are eligible to be reimbursed for payments under the Act to employees from a newly established state fund.

#### July 1, 2021 Marked Expansion of MA PFML

Please remember that the MA Paid Family Medical Leave, effective January 1, 2021, was expanded as of July 1, 2021. It now applies not only to the serious illness of an employee, but also to FAMILY LEAVE so the employee may care for a family member with a serious health condition or manage a qualifying exigency arising from the family member's call to active duty. When employees apply on-line to the Department of Family Medical Leave, they will see that the 12-week allotment may be impacted by family bonding or other leave taken between January 1 - June 30. At all times, the determination of serious illness and eligibility for leave / amount of leave, rests with the Department of Family & Medical Leave and not the employer.

#### **PLANNING AHEAD FOR 2022**

#### INCREASE IN MINIMUM WAGE

As of January 1, 2022, the minimum wage in MA will be \$14.25 and the tipped minimum wage will be \$6.15.

#### **REDUCTION IN PREMIUM PAY RATE**

As of January 2022, the premium pay rate paid by RETAIL employers will be 1.1 x the regular hourly rate.

#### MA PREMIUM PAY HOLIDAY FOR RETAIL EMPLOYERS

New Year's Day, Memorial Day, Juneteenth (6/19), Independence Day, Labor Day, Columbus Day, and Veterans Day are holidays where retail employers must pay a premium hourly rate to <u>non-exempt employees who work on those days</u> (until premium obligation phases out on January 1, 2023) <u>and cannot require employees to work</u>.

#### HOLIDAY LIST APPLICABLE TO RETAIL AND NON-RETAIL

If your business is closed on any of these dates, you are <u>not</u> required to pay your hourly employees. Keep in mind that if all of their friends and relatives are off and paid for those days, morale and recruitment at your business may be impacted.



#### Windows 10 will soon tell you whether your PC is ready for Windows 11

Currently, to check whether you're eligible to upgrade to Windows 11, Windows 10 users must use the recently revamped preview version of Microsoft's PC Health Check tool (the one that was briefly released when Windows 11 was first announced and then swiftly pulled due to issues). Soon, Windows 10 users will be getting a direct message from Windows Update on the compatibility status of their PC.

Assuming all is well, you'll receive the following message: "Great news – your PC meets the minimum system requirements for Windows 11. Specific timing for when it will be offered can vary as we get it ready for you. Note: Some Windows 10 features aren't available in Windows 11. Certain apps and features may have additional requirements."

Or, on the other hand, you'll be told that your machine won't support Windows 11. A link is also provided by Windows Update so you can check out the exact device specifications required for the revamped version of the operating system.

This process is Microsoft's "early warning" system which should help users realize that it might be time to replace that old clunker of a computer with something

newer with more bells and whistles.

Mainstream support for Windows 10 ends October 13, 2020 and extended support ends on October 14, 2025. Although Microsoft is ending support for Windows 10 on October 14th, 2025, both levels could well go beyond those dates since previous OS versions have had their support end dates moved forward after service packs. Windows 10 users will still receive automatic updates, which at some point could be considered a service pack.

But what do the terms "mainstream support" and "extended support" mean? Most importantly, both indicate that the operating system will be updated with critical security fixes as new threats or vulnerabilities are revealed. Updates can also include reliability, performance, and compatibility fixes..
